I. ISINGENISO

I-Experian yinkampani yeziinsizakalo zolwazi ehamba phambili, okuchaza ukuthi sibhekellela noma sinakekela imiqingo ngemiqingo yedatha. Sisalokhu sizinikele futhi sizibophezele ukusebenzisa idatha ngendlela eqotho ukuze sizokwenza umehluko omuhle kuwena. Kulo mhlaba wesimanjemanje, ocebe kakhulu ngedatha ungakkohlwa kalula ukulandelela indlela idatha eqondene nawe siqu esetshenziswa ngayo, yingakho sisebenza kanzima ukukuvezela obala ukuthi yini esiyiphethe futhi siyisebenzisa kanjani.

Le manuwal ikuhlinzeka ngolwazi olumayelana nolwazi esinalo noma esilugodlile kanjalo nenqubo okumele uyilandele ukuze ufinyelele olwazini olugodlwe yi-Experian South Africa (Pty) Ltd kanye nezinkampani ezingaphansi kwayo okuyilona abanesibopho sobuphathi ngaphezu kwalo. Lapho khona le manuwal ikuhuma nge-Experian, ibandakanya nezinkampani ezingaphansi kwayo ezibalwe kwiSijobelelo A esinanyathiselwe lapha.

Le manuwal ilungiswe ngokweSigaba 51 soMthetho Wokukhuthaza Ukufinyelela Olwazini, onguNombolo 2 wezi-2000 (“**PAIA**”) kanye nokubhekellela izidingo zoMthetho Wokuvikelwa Kolwazi Oluqondene Nomuntu Siqu, wezi-2013 kanye neMithethonqubo yawo, ikakhulukazi uMthethonqubo 4 (“**POPIA**”).

Inhlosi yale manuwal ngaleyi ndlela yilena:

- (ii) phakathi kwezinye izinto, wukuchaza kabanzi injongo ebangela ukuba Ulwazi Oluqondene Nomuntu Siqu lucutshungulwe; incazel yemikhakha Yabanikazi Bedatha okuyibona i-Experian Ebacubungulela Ulwazi Oluqondene Nabo kanjalo nemikhakha yoLwazi Oluqondene Nabanikazi Bedatha; abemukeli bedatha okuyibona okungenzeka bahlinzekwe Ngolwazi Oluqondene Nomuntu Siqu kanye nokudluliswa kwedatha ngaphesheya kwemingcele ngaphansi kwe-POPIA.

Sicela uqaphele ukuthi izicelo zokufinyelela olwazini kanye nokulungiswa, ukucishwa noma ukunqanyulwa kokucutshungulwa kwedatha ngokwezigaba 23 no 24 ze-POPIA ngokwehlukana kumele kwenziwe ngokwe-[Trust Centre](#) yethu.

III. AMAREKHODI AGCINWE YI-EXPERIAN KANYE NEZINKAMPANI EZINGAPHANSI KWAYO

(i) Izidalulo ezenziwa ngokuzithandela nangokuzenzekela (isigaba 51(1)(c))

Kuze kube manje, azikho izaziso esezishicilelwé maqondana nemikhakha yamarekhodi atholakala ngokunzenzekela ngaphandle kokufakelwa isicelo sokufinyelwa ngokwesigaba 52(2) se-PAIA. Lezo zincwadi esezipholakala kakade yize kunjalo zingafunywana kwiwebhusayithi yakwa-Experian South Africa: www.experian.co.za. Olunye ulwazi oluthe xaxa oluhlobene nezincwajana zokuthengisa, izinsizakusebenza zokukhangisa kanye nokunye ukuxhumana nomphakathi luyatholakala ngemuva kwezikhathi ezithile.

(ii) Amarekhodi atholakala ngokomunye umthetho (isigaba 51(1)(d))

I-Experian igcina amarekhodi ngokomthetho obalwe kwiSijobelelo B inqobo nje uma usebenza emisebenzini yethu esiyenzayo.

Sicela uqaphele ukuthi yize sisebenzise konke okusemandleni ethu ukuhlinzeka ngohlu lwemithetho efanelekile, kusengenzeka ukuthi lolu luhlu aluphelele. Sizolubuyekeza lolu luhlu uma sesinolwazi lokuthi umthetho okhona njengamanje noma omusha uyamvumela Umuntu Ocelayo ukufinyelela olwazini ngezinye izizathu ezihlukile kunalezo ezivezwe kwi-PAIA. Uma Umuntu Ocelayo ekholwa ukuthi ilungelo lokufinyelela kwirekhodi likhona ngokomunye umthetho obalwe ngenhla noma yimuphi omunye umthetho, Umuntu Ocelayo kudingeka ukuba akhombise ukuthi yiliphi ilungelo lezomthetho isicelo esenziwe ngaphansi kwalo, ukuze anikeze Umlawuli Wolwazi ithuba lokucubungula isicelo ngakulelo hlangothi. Ngaphezu kwalokho, ukutholakala kwezincwadi/imibhalo kanye namarekhodi kungenzeka kuncike kwizizathu zokwenqaba ezivezwe kule manuwalı.

Uma umthetho udinga ukuba abakwa-Experian benze ukuthi amarekhodi athile atholakale ukuze ahlolwe, abakwa-Experian bazokwenza lokho inqobo nje uma kungekho omunye umthetho noma isivumelwano esivimbela abakwa-Experian ukuba benze kanjalo, ukufinyelela kucelwa umuntu onentshisekelo futhi ofanelekile ukuthola lolu lwazi futhi kwensiwa ngokwezidingo kanye nemibandela nemiyalelo ye-PAIA; umthetho othile kanye nezinqubomgomu zakwa-Experian zangaphakathi kanye nezinqubo.

(iii) I-Experian igcina izinhlobo zolwazi olwehlukahlukene (njengokwesigaba 51(1)(e)).

I-Experian izogcina amarekhodi maqondana nemikhakha ebalwe kwiSijobelelo C.

(iv) Ulwazi-jikelele

Sicela uqaphele ukuthi imibhalo/izincwadi ezigcinwe abakwa-Experian ngokwezigaba 51(1)(d) no (e) ze-PAIA azitholakali kalula nangokushesha futhi kungenzeka zincike kwizizathu zokwenqaba ezivezwe kule manuwalı. Sonke isicelo sokufinyelela kulezi zincwadi/imibhalo sizobuyekezwa ngasinye ngasinye futhi abakwa-Experian baligodlile ilungelo lokwenqaba ukuvumela ukufinyelelwia kwamarekhodi ngokwemihlinzeko ye-PAIA. Noma yisiphi isicelo solwazi sidinga ukusekelwa ngokwezigaba 63 kuya ku-67 ze-PAIA.

IV. IZINQUBO ZOKUFAKA ISICELO NGOKWE-PAIA

Umuntu Ocelayo kufanele asebenzise ifomu elibekiwe ukufaka isicelo sokufinyelela kwirekhodi. Ifomu lokufaka isicelo liyatholakala ku-<https://www.experian.co.za> noma emahhovisini ethu. Lesi sicelo kufanele sifakwe eSikhulwini Esengamele Ulwazi ekhelini, enombolweni yefeksi noma ekhelini lezincwadi elisebenza ngobuxhakaxhaka bukagesi lakwa-Experian.

Umuntu Ocelayo kufanele athobele zonke izidingo zokwenziwa kwenqubo ye-PAIA eziphathelene nesicelo sokufinyelela kwirekhodi aphinde ahlinkeze ngokukhethekile imininingwane egcwele eformini lokufaka isicelo ukuze avumele inhloko yomgwamanda ozimele ukuba ikwazi ukuhlonza irekhodi kanye noMuntu Ocelayo. Umuntu Ocelayo kumele aphinde akhombise ukuthi yiluphi uhlolo lokufinyelela oludingekayo. Umuntu



Ocelayo kumele aphinde futhi akhombise uma kumele kusetshenziswe enye indlela yokwazisa Umuntu Ocelayo futhi asho ulwazi olufanele oludingekayo ukuze abakwa-Experian bezokwazi ukuphendula.

UMUNTU OCELAYO KUFANELE AHLONZE ILUNGELO OKUDINGEKA LISETSHENZISWE NOMA LIVIKELWE APHINDE AHLINZEKE NGENCAZELO YOKUTHI KUNGANI IREKHODI ELICELWAYO LIDINGEKA UKUZE KUSETSHENZISWE NOMA KUVIKELWE LELO LUNGELO.

Uma isicelo sifakwa egameni lomunye umuntu, Umuntu Ocelayo kufanele ahambise ubufakazi besikhundla esenza Umuntu Ocelayo akwazi ukufaka isicelo ukuze abakwa-Experian bezogculiseka.

Sizophendula esicelweni sakho ezinsukwini ezingama-30 (okungenzeka zilulwe ngezinye izinsuku ezingama-60) zokwamukela isicelo esisemthethweni futhi esiphelele ngokukhombisa ukuthi isicelo sakho sokufnyelela ulwazi sivuniyiwe nomu sinqatshiwe. Sicela uqaphele ukuthi ukugcwaliswa ngempumelelo kanye nokuhanjisa kwefomu lesicelo sokufnyelela akuvumeli ngokuzenzekela umuntu ocelayo ukuba afinyelele kwirekhodi eliceliwe.

Isikhathi esiyizinsuku ezingama-30 (amashumi amathathu) esishiwo ngenhla kungenzeka silulwe ngokwenziwa kwesaziso ngesinye isikhathi esiyizinsuku ezingadluli kumashumi amathathu (30) uma isicelo sidinga ulwazi olukhulu kakhulu, isicelo sidinga ukuthi kwensiwe uphenyo lolwazi olugcinwe kwelinje ihhovisi lakwa-Experian futhi ulwazi alukwazi ukufunywana esikhathini esiyizinsuku ezingama-30 (amashumi amathathu) zokuqala.

Ukufnyelela kuzovunyelwa kwirekhodi kuphela uma imigomo elandelayo igcwali sekile:

- Irekhodi lidingekela ukusetshenziswa nomu ukuvikelwa kwelungelo nomu yiliphi;
- Umuntu ocelayo uyahambelana nezidingo zokwenziwa kwenqubo evezwe kwi-PAIA ephathelene nesicelo; futhi
- Ukufnyelela kwirekhodi kunganqatshelwe ngokwanoma yiziphi izizathu zokwenqaba njengoba ziveziwe kwiSahluko 4 seNgxenye 3 ye-PAIA.

Umuntu Ocelayo kufanele akhokhe imali enqunyiwe futhi uma kwenzeka, idiphozithi, ngaphambi kokuba kwensiwe nanoma yiluphi ucutshungulo.

V. IZIZATHU ZOKUNQATSHELWA KOLWAZI

Isikhungo esizimele njenge-Experian sivunyelwe kuphela ukwenqaba isicelo sokufnyelela olwazini ngenxa yeziqathu ezilandelayo:

- Isigaba 63 sihlinzekela ukuvikelwa ngempoqo kobumfihlo bomuntu wesithathu obandakanyekayo ongumuntu phaqa.
- Isigaba 64 sihlinzekela ukuvikelwa ngempoqo kolwazi lwezentengiselwano lomuntu wesithathu obandakanyekayo, uma luqukethe:

- Ulwazi oluyizimfihi zezohwebo zalowo muntu wesithathu obandakanyekayo Iwezezimali, ezentengiso, ezesayensi noma ezobuchwepheshe okungathi uma ludalulwa kudaleke umonakalo ezidingweni zezezimali noma zezohwebo zalowo muntu wesithathu obandakanyekayo;
- ulwazi oluhlinzekwe ngumuntu wesithathu obandakanyekayo kwabakwa-Experian ngokubathemba, nokuwukuthi uma lolo Iwazi ludalulwa lungabeka umuntu wesithathu obandakanyekayo esimwени esingesihle ezingxoxweni noma ekuncintisaneni kwezohwebo;
- Isigaba 65 sihlinzekela ukuvikelwa ngempoqo kolwazi oluthile oluyimfihi lomuntu wesithathu obandakanyekayo uma kuwukuthi isidalulo esinjalo sizofaka phakathi ukwephulwa kwesibopho sokwethembana okumele sifezekiswe nalowo muntu wesithathu obandakanyekayo ngokwesivumelwano;
- Isigaba 66 sihlinzekela ukuvikelwa ngempoqo kokuphepha kwabantu, kanye nokuvikelwa kwempahla;
- Isigaba 67 sihlinzekela ukuvikelwa ngempoqo kwamarekhodi akhinqizwe ngemvume kwinqubo yezomthetho;
- Isigaba 68 sihlinzekela ukuvikelwa kolwazi Iwezohwebo Iwesikhungo esizimele njenge-Experian, olungabandakanya:
 - izimfihi zohwebo zakwa-Experian;
 - ulwazi Iwezezimali, Iwezohwebo, Iwezesayensi noma Iwezobuchwepheshe nokungathi uma ludalulwa kwenzeke lulimaze noma ludale umonakalo ezidingweni zezezimali noma zentengiso zakwa-Experian;
 - ulwazi okungathi, uma ludalulwa, lubeke abakwa-Experian esimweni esingesihle ezingxoxweni noma ekuncintisaneni kwezohwebo;
 - uhlelo Iwekhompuyutha (software) oluphethwe abakwa-Experian futhi oluvikelwe ngamalungelo obunikazi (copyright)
- Isigaba 69 sihlinzekela ukuvikelwa ngempoqo kolwazi lezocwaningo lakwa-Experian noma lomuntu wesithathu obandakanyekayo, uma ukudalulwa kwalo kuzobeka abakwa-Experian, umuntu wesithathu obandakanyekayo noma umuntu owenzelwa ucwaningo esimweni esingesihle neze

Zonke izicelo zizohlolwa ngokwezimfanelo zazo kanye nangokwemigomo yezomthetho kanye nomthetho osebenzayo. Izicelo zolwazi ezingenasisindo esibonakalayo noma ezimbandazayo, noma ezibandakanya ukukhwebula izinsiza ngokungenasidingo kungenzeka zinqatshwe nazo.

VI. AMAREKHODI ANGEKHO NOMA ANGEKE AKWAZI UKUTHOLAKALA:

Uma amarekhodi engeke atholakale noma engekho, Isikhulu Esengamele Ulwazi, ngokusebenzisa i-afidavithi noma ngokwenza isifungo, kudingeka sazise Umuntu Ocelayo ukuthi angeke sikhazi ukukhipha imvume yokufinyelela irekhodi elithile eliceliwe. I-afidavithi kufanele iveze imininingwane egcwele yezinyathelo ezithathiwe ukuthola irekhodi eliceliwe ukuze kuzanywe ukubona ukuthi ngabe likhona yini. Kudingeka futhi ibandakanye konke ukuxhumana okwenziwe nabo bonke abantu abenze ucwaningo.

Amarekhodi angekho noma angatholakali njengoba kusho isigaba 55 athathwa njengesinqumo sokunqaba isicelo. Uma kwenzeka ngemuva kokunikeza isaziso mayelana nerekhodi elingatholakali, bese lelo rekhodi okukhulunya ngalo liyatholakala, umuntu ocelayo othintekayo kufanele anikezwe imvume yokufinyelela erekhodini, ngaphandle uma ukufinyelela kwenqatshiwe ngezizathu zokwenqaba ezivezwe kwiSahluko 4 se-PAIA nokuyilapho abakwa-Experian benganqaba ukufinyelela ngezizathu ezithile ezikhethekile.

VII. IZIMALI EZIKHOKHWAYO:

Kunezimali ezimbili ezikhokhwayo ezhlinzekelwe kwi-PAIA, imali yokufaka isicelo kanye nemali yokufinyelela irekhodi. Imali yokufaka isicelo yimali yokwenziwa komsebenzi wokucubungula isicelo sokufinyelela irekhodi futhi ayibuyi, ngenkathi imali yokufinyelela irekhodi isetshenziselwa ukukhokhela izindleko zokuthola kanye nokulungiselela ukudilivwa kwerekhodi. Ayikho imali yokufaka isicelo ekhokhwa Umuntu Ocelayo ofuna ukufinyelela erekhodini eliquethe ulwazi oluqondene naye lowo Muntu Ocelayo siqu.

Ngemuva kokwamukelwa kwesicelo sokufinyelela irekhodi, Isikhulu Esengamele Ulwazi kufanele sazise Umuntu Ocelayo (ngesaziso, ecela Umuntu Ocelayo ukuba akhokhe imali ekhokhwayo enquuniwe (uma ikhona) ngaphambi kokuba kuqhutshewi nokunye ukucutshungulwa kwesicelo [s 54(1)].

Imali ekhokhwayo okufanele Umuntu Ocelayo ayikhokhe kwabakwa-Experian injengoba iveziwe kwiSijobelelo D. Qaphela ukuthi uma Umuntu Ocelayo kuwuMuntu Ocela olwazi oluqondene naye siqu, ayikho imali yokufaka isicelo okumele ayikhokhe.

Uma Isikhulu Esengamele Ulwazi sesisithathile isinqumo maqondana nesicelo, Umuntu Ocelayo uzokwaziswa ngeformu elifanelekile. Uma isicelo sivuniwe, lapho-ke enye imali yokufinyelela irekhodi kufanele ikhokhwe ukuze kucingwe, kukhiqizwe, kulungiswe irekhodi futhi kukhokhelwe nanoma yisiphi isikhathi esengeziwe emahoreni anqunyelwe ukucinga kanye nokulungisa irekhodi ukuze lidalulwe [s 54(6)]. Abakwa-Experian bangaphinda futhi kwezinye izimo (lapho isicelo kungenzeka sithathe ngaphezu kwamahora ayi-6 ukuba sicutshungulwe) badinge ukuba kukhokhwe idiphozithi. Inani lediphozithi lilingana no-1/3 (okukodwa kokuthathu) kwenani lemali yokufinyelela irekhodi elifunekayo.

VIII. UKUVIKELWA KOLWAZI OLUQONDENE NOMUNTU SITU OLUCUTSHUNGULWE NGABAKWA-EXPERIAN

i. Imibandela esemthethweni yokucutshungulwa kwedatha

I-Experian iyinkampani yeziñsizakalo zolwazi ehamba phambili futhi igcina imiqingo ngemiqingo yedatha yabantu kanye namabhizinisi futhi iseñenzisa idatha ukwenza imisebenzi yayo, ukuqhuba ibhizinisi layo kanye nokwenza imisebenzi ephathelene nayo njengenhlanguano, ikakhulukazi lapho icubungula khona idatha ngenkathi iqhuba umsebenzi wayo njengesikhungo esigcina ulwazi lwabathengi abathenga ngesikweletu.

Kwezinye izimo, abakwa-Experian banquma indlela kanye nenhoso ulwazi olucutshungelelwa yona, bese beseñenza njengoMcubunguli-lwazi (*Responsible Party*). Kwezinye izimo, baseñenza njengoMsebenzeli (*Operator*). Bangabuye futhi baseñenze njengoMcubunguli-lwazi obambisene nomunye.

Isahluko 3 se-POPIA sihlinzekela Imibandela eyisisekelo Yokucutshungulwa Okuseñthethweni Kolwazi Oluqondene Nomuntu Siqu nguMcubunguli-lwazi futhi abakwa-Experian bazoqinisekisa ukuthi uma becubungula Ulwazi Oluqondene Nomnikazi Wedatha benza lokhu:

- a. lucutshungulwa: (a) ngokuseñthethweni; futhi (b) ngendlela enengqondo engabuphazamisi ubumfihlo bomnikazi wedatha;
- b. bacubungula kuhela ulwazi oluqondene nomuntu siqu uma inhoso olucutshungulelwa yona igculisa ngokwanele, ifanelekile futhi ingekho ngokweqile;
- c. ngeke lucutshungulelwe enye inhoso ngaphandle uma lokho kucutshungulwa kuhambelana noma kuyamelana nenhoso-ngqangi yokuqoqwa kolwazi;
- d. bazocubungula ulwazi oluqondene nomuntu siqu kuhela uma (a) umnikazi wedatha noma umuntu ofanele lapho umnikazi wedatha kuyingane, ekuvumela ukucutshungulwa; (b) ukucutshungulwa kudingekela ukuqhutshwa kwemisebenzi yokuphothulwa noma ukusebenza kwenkontileka umnikazi wedatha ayingxenyen yayo; ukucutshungulwa kuthobela isibopho esibekwe ngumthetho phezu kwenhlanguano eqotho; (d) ukucutshungulwa kuvikela izimfuno eziñthethweni zomnikazi wedatha; (e) ukucutshungulwa kudingekela ukwenziwa ngendlela efanele kwesibopho somthetho womphakathi esenziwa ngumgwamanda womphakathi; noma (f) ukucutshungulwa kudingekela ukuphishekela izimfuno eziñthethweni zomcubunguli-lwazi noma zomuntu wesithathu obandakanyekayo okunguyena ohlinzekwe ngolwazi olugculisa ngokwanele, olufanelekile futhi olungekho ngaphezulu kwezinhliso obeluqoqelwe zona;
