### Am I obliged to provide this Personal Information?

If you are successful, we may share your Information with third parties in order to conduct preemployment checks which includes fraud prevention, employment background checks and the necessary criminal records checks as required under our recruitment policy.

We may transfer your information outside of South Africa and provide access to other Experian entities, who perform centralised functions from a Global perspective.
